#### **BACKGROUND**

The District has completed master plans for the developed parks in the District and is now researching options for financing capital projects identified in the park master plans. At the January 10, 2019 meeting Isom Advisors made a presentation on General Obligation Bonds as one option. On January 31, 2019, the Board held a special meeting and discussed other options to finance projects including municipal financing, assessments, and special taxes. At the February 14, 2019 Board of Directors meeting SCI Consulting Group presented special tax options available to the District. The Board can now discuss the various finance and community survey options in preparation for determining a course of action.
